## **Vote NO on Missouri Amendment 3**

On the November 3rd MO ballot. AAUW MO supports the effort to defeat Amendment 3. Voters overwhelmingly supported Clean MO in 2018, with all MO voting districts passing the Amendment with 62% of the vote. Some of our politicians are trying to trick voters & retract the 2018 election via Amendment 3 to manipulate an advantage for themselves.

### The following is a statement by AAUW CEO Kimberly Churches:

When the time is right, it is AAUW's fervent hope that Justice Ruth Bader Ginsburg be replaced with a justice who, like her, can be an independent voice and fierce, fair-minded advocate for American women and their families.

The time is not right. And Amy Coney Barrett is not that person.

With so much at stake, it is more essential than ever that the nominee get a comprehensive and thorough vetting. Given that the election is already underway, with hundreds of thousands of ballots already cast, there is insufficient time to hold the kind of thoughtful and deliberative hearings that the nominee — and the American people — deserve. As such, AAUW stands staunchly against filling this court vacancy until after the next president is inaugurated in January.

In addition to the issues we see with the rushed process, we are also adamantly opposed to the selection of Judge Barrett to fill Justice Ginsburg's seat. While we agree that it's essential to choose a woman for this powerful and distinguished role, women are not interchangeable. We need a justice who is committed to safeguarding our rights and advocating for AAUW's priorities with the track record to prove it. Judge Barrett is not the right person for the lifetime appointment. She is on the wrong side of many of the issues that are central to AAUW's mission of advancing gender equity. Her record of curtailing reproductive freedoms and access to health care, undermining Title IX by making it more difficult for female students to battle sex discrimination in schools, and weakening protections for workers does not bode well in ensuring that we have the advocate we need on the highest court in our land.

#### September 22, 2020 Business Meeting Minutes

President Jolene Cerveny called the September meeting to order.

#### **Old Business**

The 2019-2020 "Woman of Achievement", Sue Shineman, was recognized. Sue has always been active in her church, school and community. She is especially dedicated to the mission of AAUW, serving in many capacities and is currently serving as the Missouri State AAUW President. We are honored to have her as a member of our branch and to present her with the Woman of Achievement award.

Officers that were voted in last spring were "installed" by President Jolene Cerveny. They include Sue Raymond and Debbie White as Co-Vice Presidents of Membership; Lois Domsch as Financial Officer and Nancy Comtois as Corresponding Secretary.

#### **New Business:**

**Public Policy**-Jolene mentioned the documentary "Rigged: The Voter Suppression Playbook" was aired on September 8<sup>th</sup>. A few members did watch it. It is still available on YouTube if you have not seen it.

September 22 is National Voter Registration Day. The last day to register in Missouri before the November election is October 7, 2020; absentee and mail-in ballot request deadline is October 21. These ballots must be received at the election board office by November 3. If using this option, request the ballot early and return as soon as possible. Handouts on information about absentee and mail-in voting was available for members to pick up and share at their churches, other organizations they might be attending, neighborhoods, etc. This information was also sent as an attachment to the call for this meeting.

Check your voter registration status. It takes less than a minute, it will verify your registration, and state your polling location. Use the Secretary of State website, sos.mo.gov. This website also lists available notaries if your absentee ballot requires one. All mail-in ballots require a notary.

Finally, the Amendment 3 on the ballot addresses the issues of redistricting, lobbying and campaign financing. There will be additional information shared from the State committee on this amendment. The Missouri State AAUW's position is to vote NO on this amendment.

**Program VP**-Kathy Keeton mentioned for our October meeting our program is City of Independence COVID-19 Task Force.

**Membership**-Sue Raymond and Debbie White contacted each branch member, to invite them to the September meeting; explaining Social Distancing process for meeting in person; and providing information on connecting via ZOOM for virtual members. We had great success, with 13 members in-person attendance and 15 members and 2 guests connecting via ZOOM.

**Financial Officer**-Lois Domsch presented the financial report. (see Budget attachment) (see Financial attachment) It was moved and approved that the budget be accepted.

Lois read several notes from contributors to our 80<sup>th</sup> Anniversary fundraiser. A total of \$657.00 was contributed. We will use this money toward our Scholarship Fund.

**Corresponding Secretary**-Nancy Comtois has sent our many cards to our members. In August, Sue Shineman and Barbara Leabo. In September Judy Austin and Margaret Carnahan.

**Book Club**-Jane Campbell has had the selections for Book Club listed in the yearbook. Currently Book Club have been meeting at Jane's house.

**College/University**- Sue Shineman gave report that the Independence AAUW was asked to collaborate with the KC League of Women Voters to present Voter Registration and Voter Information to ALL KCMCC campuses via Zoom. Sue Shineman will be presenting with Stacey Webb, LWV on September 29<sup>th</sup> and October 19<sup>th</sup>. These calls will be recorded for future use and student voter education.

**Fundraising**-Jolene reported that we will not have a Book Fair this coming March. Pizza Ranch is open for business, but she will check with them if they are still offering fundraisers. We are going to pilot a new idea called "MEMBERS MARKET".

So, what is MEMBERS MARKET? We will pilot it as an online silent auction. A MEMBER MARKET email will be sent to all branch members by 10AM on the day before our branch meeting. Bids for the items can be made up to 2PM. Hourly updates will be sent to members. The member with the winning bid will be announced at the business meeting. Items will be delivered to the member at the meeting or to your home after if attending via ZOOM. Checks can be made to the Branch. So where do these items come from? We ask members to donate items that they have found in closets, basements, garages and attics that are in good condition OR donate a new item. See Jolene to donate those items. A brief description, opening bid and bidding increments will accompany a picture of the item. Send your bid by replying to the sender only, i.e. me.

Seed Sale is another idea she suggested. It would be \$2.96 for a package of seeds. Various types of seeds could be sold.

**Publicity**-Judy Tyson sent Kim Churches article on "Title 9", to the Examiner for publication. She was told if you send the article to "Letter to the Editor", it will get to press faster.

**Yearbook**-Patty Chadwick passed out the new yearbooks for the year. She will contact the members who were not present to meet with them and handout the yearbook.

**Women of Achievement**-Joyce Gillespie will have forms for members to nominate candidates for the 2020-2021 Woman of Achievement.

### **Other Business:**

We still have **suffragist** yard signs available.

Sue Raymond reported on the AAUW **Inclusion & Equity** initiative. AAUW has always supported equality for all persons. With the current social justice issues, AAUW put together a new committee "Inclusion & Equity". (see AAUW National for more information.) Each state team set their own goals; Missouri's groups is discussing the book "Waking Up White", examining our *own unintentional biases.* Each branch is encouraged to include programming to include I&E topics; however the Missouri Committee was formed after Independence Branch programming had been scheduled. Sue Raymond and Courtney Yount-McGinnis are on the Missouri Team, and they hope throughout the year, to introduce Inclusion & Equity in our meetings.

Jolene read a statement from AAUW CEO Kimberly Churches on behalf of Ruth Bader Ginsburg...

"America lost one of our most beloved role models tonight, a pioneering jurist and iconic feminist who blazed new trails, not only in her own life, but in the lives of the countless women she championed—and inspired. On behalf of AAUW and its members and supporters who recognized Justice Ginsburg with a 1999 AAUW Achievement Award, we extend our condolences to her family, her colleagues and to every American whose lives and hearts she touched. The nation owes it to her - and to all women - to honor her final wishes and refrain from naming a replacement until after a new president is inaugurated."

We had a moment of silence for Ruth Ginsburg.
