January 26, 2021 = AAUW Program

Our guest speaker, Jane McClain presented "Failure Is Impossible", the history of women's suffrage in Missouri, Kansas and beyond. Two guests from the Booneville branch and one guest from the Columbia branch joined us for this program.

January 26, 2021 = AAUW Branch Meeting

The January meeting was called to order by President Jolene Cerveny.

No additions or corrections to the minutes from our November meeting published in the newsletter, they stand approved.

<u>VP, Program</u>: Kathy Keeton reported that February's program will be a panel discussion about the burden of student loan debt for college graduates. The panel members will be Mindy Hager, Dena Norris, and Sarah Morris.

Public Policy: Renee Freers asked us "Why did you join AAUW? One member said, "to meet people your own age". Another member said, "to be with dynamic women". Renee reported highlights of the Missouri Women's Network Legislative Retreat she attended. This Zoom event brings many resources together which all work to advance the rights of women. Several resources shared include: **VOTE411.org**; which is the League of Women Voters information, and the AAUW website, **aauw.org. FastDemocracy.com** is a free website that provides information on legislative bills affecting women.

Public Policy (cont'd)

Kelley Reetzke wanted to cover two bills of significant interest in Missouri.

SB 59 - modifies provisions relating to employment practices relating to gender.

SB 143 – creates new provisions governing employer hiring practices. (i.e., about your salary history).

Federal bill the Paycheck Fairness Act includes steps to update and strengthen the Equal Pay Act of 1963; to help close the gender pay gap.

Membership: Sue Raymond asked us to please send email notes to her about what we have been doing, in an effort to stay in touch. Members also shared of memories of Judith Gutekunst.

Financial Officer: Lois Domsch presented financial report (see Financial attachment)

Corresponding Secretary: Nancy Comtois sent out cards in January. A Get-Well card to Judith Gutekunst. Sympathy cards to Karen Johnson, Lisa Cox, and Judith Gutekunst families.

Book Club: Jolene reported for Jane. Book Club was postponed for a month. Will be meeting in February.

Fundraising: Jolene reported the January Members Market made \$96. Next Market will be February 22.

<u>Publicity</u>: Jolene reported about taking out an ad in the Examiner, "Thanking our Heroes". After discussion, it was moved and seconded that the branch proceed with placing a quarter page "thank you" ad in the Independence Examiner, crafted by Pat Bounds and Barbara Leabo.
