Harassment, Bias Drive Women Away from Lucrative Manufacturing Jobs

The study explores the challenges women face in male-dominated industries and the barriers that hinder their success. The report also outlines how employers can build a more competitive workforce by addressing these longstanding issues and creating more pathways for women in the manufacturing fields especially as we begin to rebuild our economy after the pandemic.

Each member received an email on or about April 7, 2021 from Shannon Wolfe, AAUW. The Subject Line: Vote now to shape AAUW's future, includes your personal link to vote. Please make note of your Member ID and PIN, as you will need to enter them to vote. Click on the VOTE NOW button to get started.

This year, members' voices will determine our path forward as an organization. We are asking you to vote on amendments to our Public Policy Priorities and bylaws, including a proposal to eliminate AAUW's longstanding membership degree requirement. You will also vote on four candidates to rejoin AAUW's 15-person board of directors.

In 2021, there is enormous pressure on long-standing organizations like AAUW to compete with new and emerging organizations like Times Up, Girl Up and Girls Who Code. AAUW must meet the challenge of remaining relevant in 2021 and into the future. That requires opening membership and increasing our Diversity, Equity, and Inclusion efforts.

Your AAUW MO Board supports both the elimination of the degree requirement and the bylaws changes. We encourage you to vote online to ensure your ballot will be received and counted immediately. Paper ballots have been mailed to those without email addresses on file and must be postmarked by Friday, April 30, 2021.

Please VOTE today! Your voice and your vote are vital. The future of AAUW is in your hands.

Finance Committee Report to the Branch Membership

In our finance committee meeting 3-13-21 we addressed 2 questions: What are our goals for our money? Where should the money sit?

Our two goals are:

- 1. Help high school girls become more successful in life by relieving educational debt. Supporting them how and when we can. Continue a relationship with them; aid doesn't stop with just money; provide leadership opportunities, discussions on equity; introduce them to what AAUW has to offer them as college women, i.e. NCCWSL, webinars, etc.
- 2. Address "issues" in the community and AAUW MO priorities, i.e. diversity, equity, inclusion, public policy, college/university, education. Identify where we can have an impact and implement an action plan.

Where should our money sit?

- We will continue to retain money in our bank account for "issues" we wish to support, whether it be Re-Entry Scholarships, Special Projects, Conferences, Leadership training, etc.
- Money for educational aid to ISD students will be in the ISDF.

How should our money sit in the ISDF?

- 1. ISDF "temporarily restricted" fund This is what we have now. It draws no interest. We can "spend it down" to zero for ISD students.
 - If we leave it as "temporarily restricted" we can spend it down yearly for our 3 scholarships for 10 years till it is all gone.
 - In the meantime, we can allocate our fund-raising money for other "issues."
 - When ISDF money is all gone we would have to start funding our educational projects with money generated each year. Year-by-year we have no guarantee what our fund-raising efforts will bring.
 - Without an account with ISDF, we could no longer claim the 501©3 status provided through association with the ISDF. Yet, for most individuals that is no longer a concern for tax purposes; however, it might be if we are able to partner with businesses and corporations.
- 2. ISDF endowment We can sign a contract and convert our money in that account, \$16, 341, into an endowment. Add additional money to bring it up to \$20,000. It will draw 4-5% return which we can apply towards educational opportunities for ISD students.
 - The corpus, or base of money we have put in the account, is the property of the ISDF and we will get a percentage of that to use each year, based on the growth of their investments.
 - We will be assured that some portion of the money we wish to give for scholarships or other educational activities in the ISD is already funded and we would have to add less to make up the difference.
 - Any unspent money during the year converts to the corpus. The corpus is owned by the foundation forever, but it is invested and could grow, so the 4-5% could be larger.
 - If our branch ever dissolves, the ISDF keeps the investment we made.

Come with questions to the meeting and/or contact Lois or any other committee member to clarify the choices. We will vote on how to handle the ISDF account at the April meeting.

1.) March 24th, was the day that marked how many days working women lose money for. In other words, since we get paid 82 cents to the \$1 of a man we basically had been working for free since Jan. 1st.

2.) Pay Check Fairness passed in 2020 and is being considered again.

3.) ERA Progress passed with bipartisan support (yea) to remove the arbitrary deadline to ratify. This is great news.

4.) Education bills in MO are being considered that will hurt public schools dramatically. If we are interested in increasing inclusion and equity there is no more important way to do that then keep our public schools strong and well-funded. There are bills to send money away from public education...to voucher programs, to private schools, and home schools. Be looking for information and be aware of what they are doing.

March 23, 2021 Business Meeting

Kathy Keeton introduced our guest speaker tonight: Sue Shineman.

Sue joined AAUW in 1972; served a four-year term as our branch President, and is currently Missouri AAUW State President. She hosts monthly Zoom calls for four Missouri State branches including our Independence branch.

In her "State of the State Address: AAUW Style" Sue reminded us about the National Vote starting on April 7th. Members will get an email enabling them to cast a vote on two issues. The first issue is the 2021-2023 policy priorities: diversity, inclusion and equity being a key focus. This would be a "Yes" vote. Second issue is to eliminate degree requirements for AAUW membership. We need to have an" open door" policy. This would also be a "Yes" vote. On the state level, a task force will coordinate the work of the College & University, Public Policy, and Inclusion & Equity committees. May 1st is the MO State Annual Meeting, it will be held virtually, from 9:30 – 11:30AM.

Nominations – Jolene thanked Karen Johnson, Patty Chadwick, and Karol Palmer for serving on the Nomination committee. With a show of hands, the candidates for 2021-2022 officers were unanimously elected. They are: President: Renee Freers; Vice-President, Program: Pat Bounds and Recording Secretary: Gail Metcalf Schartel. Installation of new officers will happen at the May meeting.

<u>Finance</u> – Lois Domsch led the discussion on the Finance Committee report (see attached) addressing our ISDF fund. One option is to leave the fund of approximately \$16,000 at its current status ("temporarily restricted" fund), and spend it down over the next 10 years. The other option would be to add funds and convert to an endowment of \$20,000 in the ISDF, using the interest to fund scholarships. Interest earned would be between 4-5%. If our AAUW branch dissolved in the future, these funds (\$20,000) would go to the ISDF.

There was also some discussion about using a financial advisor in regard to the money in our Community America saving account. Also discussed was the possibility of investing in money market and/or in other types of accounts where more interest could be generated. Also discussed was the idea of using our scholarship funds to support students taking dual credit classes.

The money in the ISDF has to be used for Independence students. That could be in our current scholarships, or in dual credit classes, STEM camps, or assemblies. The funding of other community activities was also discussed. ISDF funds could not be used for community activities. We will vote on how to structure our investment at ISDF at the April meeting; make it an endowment or spend it down.

Fundraising – Jolene reported on our recent fundraising and thanked those who worked at the Pizza Ranch event. That event raised \$437.69, (we made \$269.00 in tips alone)! ½ Price Book Sales: \$133.25. The Flower Power sale will end Friday March 24th. The branch will make 50% of those sales which are currently at \$700. March's MEMBERs MARKET netted \$55.00.

<u>VP. Program</u> – Kathy Keeton reported our presentation in April will be Independence High School Student Awards by Kathy Vest. Also, recognition of our 2021 Woman of Achievement by Joyce Gillespie.

March 23, 2021 Business Meeting (continued)

<u>Corresponding Secretary</u> – Nancy Comtois sent "Get Well" card to Debbie Barkley and a "Sympathy" card to Sue Raymond.

<u>Membership</u> – Sue Raymond excitedly mentioned that we had 23 members at our Zoom meeting tonight. She also requested help with contacting other members who have not been attending the meetings this year. If other members would not mind making a call to them.

Book Club – Jolene reported the next meeting will be April 13th in Jane Campbell's garage. The book is "The Yellow Bird Sings" by Jennifer Rosner, discussion to be led by Jane Campbell.

Bylaws/Parliamentarian – Sue Shineman reported she has been working on bylaws and standing rules. After the National vote, she will update and bring up at the June board meeting.

<u>Newsletter</u> – Lisa Cox requested that board members need to have their reports to her by the 7th of April. Lisa also asked members to review changes to our website.

Public Policy – Renee Freers spoke to the significance of March 24^{th,} Women's Equity Day, explaining this is essentially the first day of the year women get paid as they are make \$.82 on the dollar earned by men. The Paycheck Fairness Act has been introduced. It would ensure individuals cannot be asked about their earning history. This practice has been used to keep women's salaries lower. The ERA (Equal Right Amendment) received a bipartisan support to remove the arbitrary deadline for ratification. The large number of states that have not yet ratified, they can continue to work toward that.

<u>**Re-Entry/ Student Awards**</u> – Kathy Vest reported 19 applications were received this year for the re-entry scholarships. The recipients of these awards will be announced at an April 17th Zoom event.

For the high school scholarships, there were fourteen applicants from Truman High School, seventeen from Van Horn High School, and eleven from William Chrisman High School. The applications were reviewed and the top three students from each high school were submitted. This year we are awarding scholarships of \$750, which will be a big surprise for the students. These awards will be presented at our April 27th meeting.

<u>Woman of Achievement</u> – Joyce Gillespie reported we have received one excellent nomination for Women of Achievement. She will get together with Sue Raymond, so they can be in contact with this person. Recognition of our 2021 Woman of Achievement will also be done at our April meeting.

Jolene will be sending out the Star Award application to all officers and committee chairs for input. She will submitted by March 30th.
