## AAUW Independence Branch January 23, 2024 Meeting Minutes

Karol Palmer called the meeting to order at seven o'clock and introduced the evening's speaker, Jennifer Hurst, Chief Development Officer of the Community Services League.

Ms. Hurst introduced herself and explained that she had been involved with non-profit organizations for most of her professional life, including domestic violence shelters, foster care and others involved with helping individuals achieve a sound footing in life. She then shared a video of Cindy Chowning, a graduate of the Family Self-Sufficiency Program offered by the Community Service League (CSL). Ms. Hurst explained that SL serves the most urgent needs of the community by assisting with food, clothing, utilities and housing needs. More than 20,00 clients a year seek help from the CSL. More information can be found at <a href="www.cslcares.org">www.cslcares.org</a>. She talked about the Independence Together program initiated in the fall for three months to employ homeless individuals to pick up trash in Independence, receiving payment each day. The hope is to expand the program.

She noted that a fund raiser for the Community Services League would be held by Rotary on February 18<sup>th</sup>. [For more information on this go to Home Page | Rotary Club of Independence (clubrunner.ca)]. The hope is to raise sufficient funds to open a Drop-in Center near I-70 and Sterling Avenue in the basement of a Community of Christ building. The facility would serve as a place where individuals could drop in to talk with individuals, pick up food and clothing, to use it as a mailing address and learn of other services. She noted that the Hawthorn project has been successful, allowing residents to walk across the parking lot to pick up food and clothing as needed from a designated site. Other services provided include various Christmas stores, the BlendWell Community Café [10725 E. US Highway 24] and educational programs for individuals to learn how to manage money.

Ms. Hurst noted that support can come in many ways, through volunteering and through financial support. One such way is through the 1916 Club [Donation Form (donorperfect.net)], a monthly giving program. She encouraged questions and said she was available to answer them via e-mail [jhurst@cslcares.org] or by phone: (816) 491-2011.

The group thanked Ms. Hurst for her informative presentation. A short break was then called.

AAUW Independence Branch January 23, 2024 Meeting Minutes (Continued)

Karol Palmer called the business meeting to order at 7:45 p.m.

INCLUSION INFUSION: Sue Shineman reminded the group that discussion in November was about the pro side of including women without degrees to AAUW. She asked for reasons against this change. The only response was the question of the organization's name. Sue noted that other organizations including the YMCA and AARP had not altered their names when they adopted broader definitions of inclusion. She noted that members would receive an email from vote@simplyvoting toward the end of March to vote on the amendment to the by-laws. She encouraged members to review information on the AAUW website prior to voting. Voting will be open from April 3<sup>rd</sup> through May 15<sup>th</sup>.

Sue noted there were two webinars being offered on January 31<sup>st</sup> by the Inclusion and Equity Committee and on February 7 by the Public Policy Committee.

FINANCE: Karol reviewed items from the February financial statement, including the fact that \$457 had been raised at the holiday luncheon and \$210 had been sent to the Fisher House.

PROGRAM: Sue Raymond noted that Montel Evans will be the speaker at the February meeting. Karol noted that City Councilwoman Bridget McCandless would speak at the March meeting and asked members to submit questions for Dr. McCandless at the February meeting.

COLLEGE/UNIVERSITY: Barbara Leabo reported that Longview Community College has reached out and asked for help registering students to vote. On March 5 a group including Barbara, Sue Shineman, Lois and Patti Petet will go to Longview to assist. The next visits to Blue River Community College will be on March 19<sup>th</sup> for Equal Pay Day and April 9 Sexual Assault Awareness. She noted that teal is the official color for sexual assault awareness.

MEMBERSHIP: Barbara Leabo said that she hoped to get a group together to attend the Community Theater's play, Anne Frank, on either April 5<sup>th</sup>, 6<sup>th</sup> or 7<sup>th</sup>. She will have more information at February meeting.

SCHOLARSHIPS: Jolene reported that a new scholarship at Blue River Community College would be for a female, graduating from BRCC, having used the A+ program and continuing her education would be posted to the ScholarWise site once an application had been developed and linked. She noted that A+ does not cover books or fees so a \$500 scholarship would be a boost. There was discussion about whether to restrict this to those finishing the program or being currently enrolled at BRCC. The Scholarship Committee will develop and application form and share it at the next meeting.

FUND RAISING: The next Pizza Ranch volunteer event would be held on April 15 from 5-8 p.m. Volunteers will be needed.

HOSPITALITY: Jane Campbell thanked Lois Domsch and Barbara Leabo for providing goodies. She asked for volunteers for February. Pat Bounds and Jan Keeler volunteered.

NOMINATIONS COMMITTEE: Karol announced that Kathy Vest, Jolene Cerveny and Joyce Gillespie were elected by the Board to serve on the Nominations Committee and would be seeking candidates for membership vice president, finance officer and corresponding secretary. A slate of officers will be presented at the March meeting.

Karol reminded members that newsletter articles were due to Lisa Cox by February 8. She noted that applications for the Woman of Achievement were on-line and that she could also provide them. Nominations for Woman of Achievement are due by March 31.

INTERNATIONAL WOMAN'S DAY: Sue Shineman noted that on Friday, March 8, at 6 p.m. an International Woman's Day celebration would be held at First United Methodist Church and would include several churches from the Square area and would include a light meal. She encouraged members to send her lists of any other organizations that might want to attend. She also suggested that members wear white and yellow sashes about getting the vote for women. RSVPs are needed to insure sufficient food is prepared.

RE-ENTRY BRUNCH: KC-IBC Entry Brunch will be held on April 13 at 11 a.m. It will be a fund raiser. Sue Shineman indicated she will need 6 volunteers to help prepare, set up and clean up. In addition, she will ask other branches to help. The cost is \$30 per person with proceeds going to the Re-Entry Scholarship. That scholarship will also be on ScholarWise website.

LEGISLATIVE RETREAT: A Legislative Retreat will be held February 24 from 9-11:30 a.m. via Zoom. Missouri legislative updates will be discussed.

ANNOUNCEMENTS: There will be a Community Services League fund raiser at 3 Trails Brewing Friday, January 26 from 5-10 p.m. Aaron Crossley will be one of the bartenders. \$1 from every beer sold will go to the CSL; there will be a 50/50 raffle, and a coat drive (collecting coats for those in need).

T-SHIRTS: Patty Chadwick noted that t-shirts are ready but the shop was closed when she went to pick them up. The cost is \$20 and she will have them at the next meeting.

Melissa Morawitz won the door prize and the meeting adjourned at 8:30 p.m.
