Elementary students at Proctor Elementary are enjoying hands-on STEM activities in their library classes. After reading the book Whoosh, about the inventor of the Supersoaker, to her 3<sup>rd</sup> grade class, Ms. McHenry had the students design a prototype for a new toy. To another group she read Ricky the Rock Who Couldn't Roll and had the students find a way to make a rock roll down a hill, not slide, using materials such as foil, playdoh, rubber bands, pipe cleaners, etc. With her kindergarteners she read I Have a New Toy and had them design a fidget spinner top. First graders got to create an idea to go along with the book If I Built a School using Legos or other choice of building materials. ## Open Enrollment (aka "School Choice").

Open Enrollment would allow students to attend a Missouri public school of their choice, without residency restrictions. There are a number of considerations raised by Open Enrollment; allocation of tax dollars, ethics of educating all students, transportation concerns, and classroom size, to name a few.

The current versions of legislation supporting Open Enrollment in Missouri are <u>SB 215</u> and the main bill on Open Enrollment, <u>HB 711</u>.\*

Attached is an informative email to the employees of Blue Springs School District from Dr. Bob Jerome, Superintendent. The message outlines the damages of "Open Enrollment" to public schools.

The bill was passed out of the Families, Seniors, and Health committee on March 3, 2025. It will come up for a state-wide vote in November, 2026.

#### AAUW Independence Branch April 22, 2025 Meeting Minutes

Karol Palmer called the meeting to order at seven o'clock and welcomed all. She introduced the AAUW Scholarship Award winner, Deryan Banks and asked her to introduce her guests and tell the group about her background, high school achievements and future plans. Deryan introduced her mother, Amber Downey, her father Dorian Banks, and stepmother, Bridget Banks. She noted that she is a senior at William Chrisman High School, plays Varsity Basketball and Varsity Soccer, was a member of the National Honor Society and had received the McCoy Award. The McCoy Award is named after William McCoy, the first mayor of Independence and is given to students who have excelled during their first four semesters of high school. She has volunteered in Relay for Life and works part time to earn money for college. Her plan is to major in Computer Engineering with hopes to develop items to assist people in their daily lives. She will attend the University of Missouri at Columbia in the fall. She will be recognized with the AAUW scholarship on May 7<sup>th</sup> at Chrisman's awards ceremony.

After being presented with a gift from the Branch members, Deryan and family left and the Branch business meeting ensued.

CENTURY CLUB RECOGNITIONS: Lois Domsch reported on the Branch members who achieved Century Club status for the year. Christina Nagel and Joyce Gillespie attained Branch level; Jan Keeler, Patt Braley, Judy Tyson, Judy Tucker, Jane Campbell and Gail Metcalf Schartel attained both Branch and State Level; Sue Shineman and Lois Domsch achieved Branch and State Plus level Century Awards. Each member present received a certificate from Lois. Lois noted that 74% (21) of Independence Branch members contributed to the funds.

Karol noted that she received word that Patt Braley was recognized as a Life Member by National in recognition of her 50 years in AAUW.

FINANCES: Patt Braley reported that as the fiscal year draws to a close, members with receipts for expenses needed to submit them to her for reimbursement. She also noted that dues for the coming year were \$98 and could be paid on-line or by giving her a check.

NCCWSL: Karol said that due to not having awarded a Re-entry Scholarship, that the Interbranch Council had agreed to support a student to attend the NCCWSL (National Conference for College Women Student Leaders) conference to be held at the University of Maryland, College Park at the end of May. She noted, too, that NASPA (National Association of Student Personnel Administrators) would be leading the conference. A motion (Chadwick/Braley) to give \$400 to support a student attending this conference was approved unanimously.

MISSOURI STATE MEETING: Members are encouraged to attend the Missouri State Meeting via Zoom on May 3, 2025 from 9:00 a.m. to noon. Karol invited those who would like to watch as a group to meet at her home between 8:30 and 9:00 that morning. Sue Shineman said the speakers were excellent. Dr. Amber Benge will speak on DEI and education and Katrina Sun Breese would discuss national membership and fundraising.

OFFICER ELECTIONS: Karol reported that a quorum of members voted to elect Kelley Reetzke and Karol Palmer as co-presidents and Gail Metcalf Schartel as Recording Secretary via e-mail. She noted the Program Coordinators: Lois Domsch, Karol Palmer, Sue Raymond, and Sue Shineman) ask that all members make suggestions for programs, events and outings. A board meeting scheduled for June 10 at 6 p.m. was one everyone should attend to discuss program ideas.

COLLEGE/UNIVERSITY: Karol reported that she and Gail had been at Blue River Community College to promote pay equity in March. Gail said that they would be at Blue River on April 23<sup>rd</sup> to share information about Denim Day and Sexual Assault Awareness Day with a display and another quiz game about issues related to the topic from 10:30 a.m. to 1:00 p.m.

FUNDRAISER: It was reported that the March 24<sup>th</sup> Pizza Ranch fundraiser had been quieter than in the past but a total of \$352.89 had been raised through tips (\$240.92) and a percentage of sales (\$111.97). Joyce Davenport will share information on the next date for the fundraiser. It was suggested that a handout be developed to distribute to people prior to the fundraising date to encourage them to dine at Pizza Ranch to support AAUW.

INTERBRANCH MEETING: Karol thanked those who attended the April 5<sup>th</sup> meeting of the Independence, Kansas City, Northland and Parkville branches. She said a good discussion had occurred and it was agreed the four branches would work to offer group programming. The Parkville and Northland branches will plan Metro sessions for October and April; the Independence and Kansas City will plan Metro sessions for November and March. In September, each branch will plan their own programs; in December a Metro Christmas project and gathering will be held; in January and February, Pathway Programs from the state with Watch Parties are planned. The idea is for the jointly planned meetings will be open to all four branches to attend. In April other events are planned: Wagy Awards in Kansas City and High School Scholarship Awards in Independence. All branches will participate in the State Meeting held in Columbia in May and a 'New Year Celebration' will be held in July. As this is a Parkville and Northland tradition, they will take the lead in planning it. The next Metro planning meeting is set for June 21, 2025, from 10 a.m. to noon and will be hosted by the Parkville and Northland branches. Times, places, and topics are to be determined for all described above.

NEWSLETTER: Lisa Cox requested that items for the newsletter be submitted by May 10<sup>th</sup>.

CITY OF INDEPENDENCE DAY OF THE CHILD: The Day of the Child event has been rescheduled for September 6, 2025 from 10 a.m. to 3 p.m. More information will be forthcoming.

MEMBERSHIP: Karen Johnson suggested that the Branch pursue putting information in the publication of community classes published and distributed by the Independence School District. She will follow up on this.

HOSPITALITY: Jane thanked Lisa Cox and Karen Johnson for providing refreshments for the evening and for those who brought food for the Metro meeting on April 5<sup>th</sup>.

DOOR PRIZE: Karol Palmer won the door prize. Karen told everyone to take home purple pansy plants she had provided.

The meeting adjourned at 8:20 p.m.
